## **Funded Hours**

All three and four year olds are entitled to a maximum of 570 hours free early education per year. (15 hours a week, term time) know as universal entitlement. Working parents may be able to access an additional 570 hours free early education per year if they meet certain criteria. For the extended entitlement you must have a valid code by the end of the month before a new term starts.
